Road

Tim Bowes gave the road report.

He gave an update on parts and the operation of the rotary cutter.

Last month's request to purchase the excavator was revisited. A Used Case CX80-C excavator and bucket was brought into consideration. There was discussion on the purchase and presentation of the bids. The total cost of the excavator and bucket would be \$66,000.96. Per the opinion from the Lucas County Prosecutor, this equipment does not have to go out for a competitive bid as it is under \$75,000 and will not be used for constructing, reconstructing, maintaining, and repairing of roads and culverts. Trustee Kester made the motion to purchase the excavator and bucket, Trustee Anderson seconded. Roll call vote: Trustee Kester: yes, Trustee Anderson: yes, Trustee Hood: yes.

Sourcewell is an organization that ensures the lowest price available (state pricing) for large purchases of equipment. Participation with Sourcewell is free of charge. There was discussion.

Trustee Anderson made a motion for the Township to join Sourcewell for large equipment purchases, Trustee Kester seconded. Roll call vote: Trustee Kester: yes, Trustee Anderson: yes, Trustee Hood: yes.

Trustee Anderson explained that the Township currently owns 3 vintage jeeps that are commonly known as brush buggies. There was discussion on their current use.

One of them is currently used for power washing purposes.

Trustee Anderson also explained that the Township owns a 1999 Ford F450 Truck and plow that is no longer needed.

He is asking that the 1954 Willys Brush Buggy Serial 41422 and 1955 Willys Brush Buggy 155B along with the 1999 Ford F450SD VIN 1FDXF47FXXEA05679 all be decommissioned and placed on Gov Deals for sale.

Trustee Anderson made the motion to decommission the 3 items above, Trustee Kester seconded. Roll call vote: Trustee Kester: yes, Trustee Anderson: yes, Trustee Hood: yes.

The bids for Gov Deals are as follows:

\$8000 for F450 Ford Truck with snowplow \$3000 for each Jeep
